**Check In and Setup:** Check in/setup at the commercial tent. Check in with Serendipity Mothers.

**Thursday June 9<sup>th</sup>** 4:00 pm – 8:00 pm  
**Friday June 10<sup>th</sup>** 12:00 pm – 2:00 pm (only if necessary).

Equipment should be fully in place by 2pm Friday June 10<sup>th</sup>, 2011. All equipment must be removed from the grounds and trash placed in receptacles by 7pm Sunday June 12<sup>th</sup>, 2011

**Tent Hours:** Friday June 10<sup>th</sup> 4:00 pm – 9:00 pm  
Saturday June 11<sup>th</sup> 12:00 pm – 10:00 pm  
Sunday June 12<sup>th</sup> 12:00 pm – 6:00 pm

**Fees:** Booths are 10 foot x 10 foot and the cost is \$75 for the first booth and \$50 for each additional booth space. You must bring your own displays and extension cords.

**Vehicles:** There is no parking permitted on the grounds. Parking passes, to park at the pool a short distance away, will be provided at check-in from the Serendipity Mothers. There is limited short term parking before and after the festival for loading and unloading.

**Booth Locations:** Serendipity Mothers will determine booth locations. A request may be made but cannot be guaranteed.

**Theme:** The 2011 Poultry Days theme is Chick-A-Ritaville

**Smoking:** No smoking is permitted in the tent. Anyone smoking will be asked to stop or to leave the tent area.

**Camping:** There is no camping or staying on the grounds over night.

**Restrictions:** Serendipity Mothers and Poultry Days reserve the right to require a vendor:

-Not to sell

- Poultry in any form (chicken, turkey, etc.)
- Cotton candy, candy apples and snow cones
- Ice cream or lemonade
- Alcohol or tobacco products
- “Chicken Hats” or merchandise utilizing the Poultry Days name in any form
- Weapons or knives
- Anything considered obscene

-Serendipity Mothers and Poultry Days reserves the right to require the vendor to immediately cease sales of any product including those that conflict with our family friendly festival.

-Vendor agrees to sell their merchandise or services from their assigned space and not to “hawk” it or sell it by walking the grounds.
